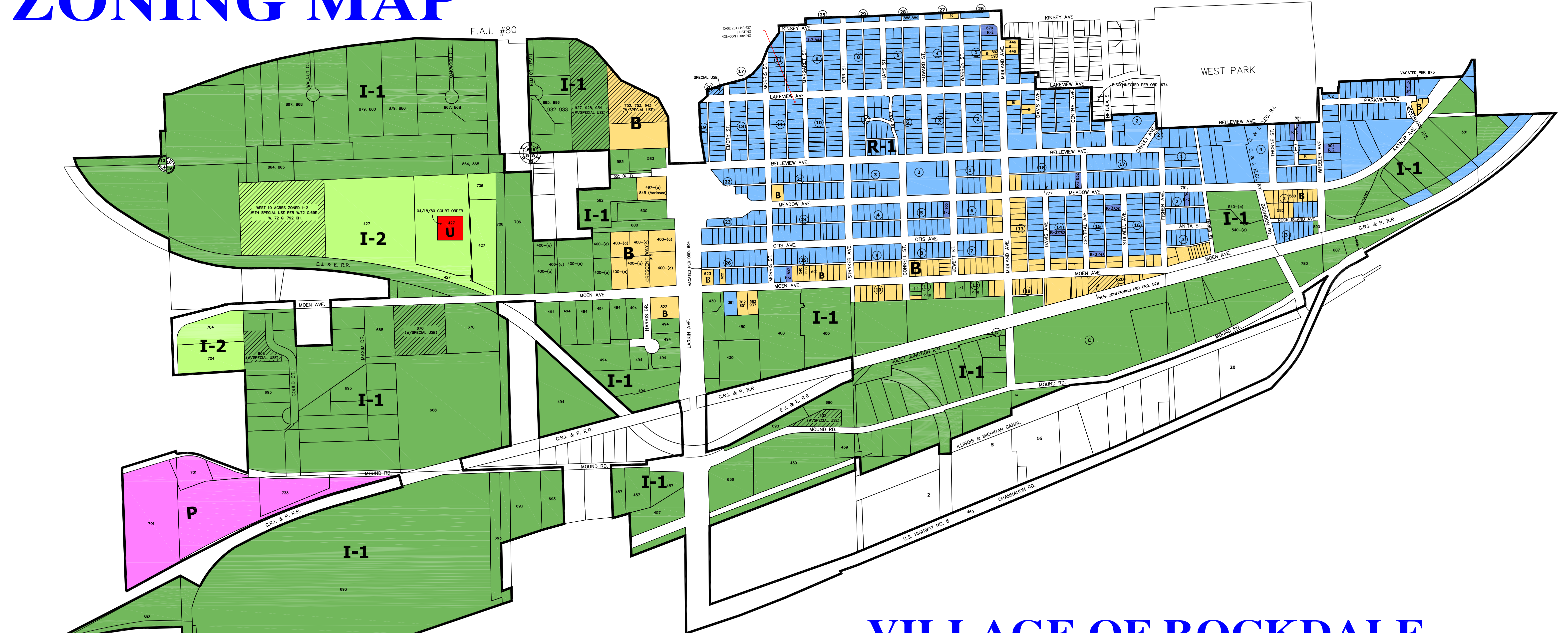


# ZONING MAP



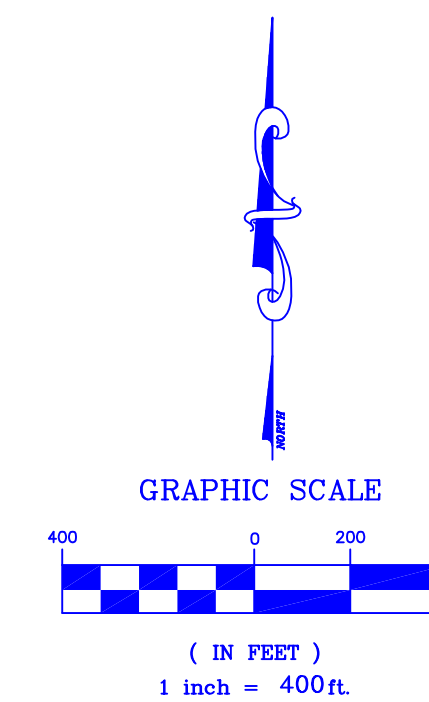
